List of 6000 Putin's War Enablers

Compiled by Alexei Navalny's Anti-Corruption Foundation – experts on Putin's regime and the corruption schemes on which it rests

Aimed at the regime's soft spots; drives a wedge between Putin and his officials

Includes 16 categories of individuals from key cogs in the system to high ranking officials

Subject to revision and updates through transparent procedure

Focused on making Vladimir Putin toxic and isolated



Pillars of Putin's War Regime:

Who Are the 6000?

Advocates

responsible for spreading propaganda lies and making Russians believe they support a “special operation” to liberate Ukrainian civilians from “Nazi Regime”

Propagandists

Unlike Putin's inner circle, most of these people would definitely feel the impact of targeted sanctions

The majority of the people on the list are no billionaires or high-ranking officials, but key cogs in the system with a relatively humble (compared to Putin's top officials) appetite for corruption.

Targeted sanctioning of their limited assets abroad and travel bans will be extremely painful and therefore effective measures for this category of people.

They need a way out

Listed people fit the criteria of the EU, UK and US sanctions regulations against corrupt officials, violators of human rights and warmongers.

The list is subject to revision and updates: many of the 6,000 people, whose hands are not covered in blood, still have a couple of months to get off the list through active repentance.

A public repudiation of rejection of the aggression against Ukraine is one of the main paths to being removed from the lists.

Why Would the 6000 List Work?

Targeting these 6000 individuals will weaken Putin's regime

In preparing this list, the Anti-Corruption Foundation has made use of its decades of experience investigating Putin's corruption and Russian politics, its actors and tendencies, and knowledge of the regime's vulnerabilities and soft spots.

They can have a future beyond Putin

The median age of the list participants is 45 y.o. — a flight risk with a chance for a "life after Putin" and no reason to sink along with him. Making it on the list forces them jump the ship; their exodus accelerates the collapse of the regime.

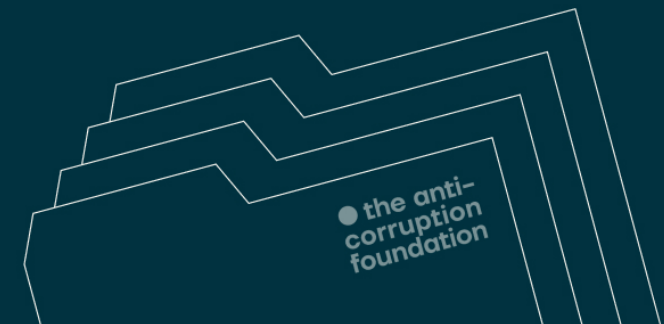
Sanctioning these people will help make association with Vladimir Putin toxic, leaving him abandoned and isolated in a scorched field

Over the next months, the ACF will be discussing the list with government officials of leading western powers.

We are confident during this time a number of people on the list will publicly step down, denounce the regime and join the forces fighting against it.

The threat of inclusion on such a sanctions list will prevent Russians with global ambitions or international assets from taking key senior and mid-level positions in Putin's team, whether publicly or discreetly.

How Would **the 6000 List** Work?



Once it is confirmed that the list may serve as a universal platform for sanctions against Putin's regime, the ACF will work on detailed profiles, matching each listed individual to each participating nation's legal requirements for individual sanctions.

This investigative work will further serve as supporting evidence for the doubtless-forthcoming international war tribunal and other truth-finding proceedings covering the war in Ukraine and other crimes of Vladimir Putin.
